

1 INTRODUCTION

Tamil Nadu Agricultural University (TNAU) is rated as one of the best Agricultural Universities in India by Indian Council of Agricultural Research, New Delhi. TNAU is an institute par excellence for higher education in Agricultural and allied subjects. TNAU celebrated its Golden Jubilee during the year 2021.

The vision of TNAU is to promote science-based agriculture and allied processes in the State of Tamil Nadu to help the farmers and agri-based industries to compete successfully in the national and international markets through its education, research and out-reach programs.

TNAU originated as an Agricultural School at Saidapet, Chennai in 1876 and blossomed as a College in Coimbatore in 1906. In 1920, the college was affiliated to the University of Madras with the introduction of a three-year degree program. Till 1946, the Agricultural College and Research Institute, Coimbatore was the only institute which offered agricultural education for the whole of South India. In 1958, it was recognized as a Postgraduate Centre for offering Masters' and Doctoral degrees. The Agricultural College and Research Institute, Madurai was established in 1965. These two colleges formed the nucleus of the Tamil Nadu Agricultural University when it was established in 1971 to offer four years B.Sc. (Agriculture) degree program.

In the year 1972, two more programs i.e., B.Sc. (Horticulture) and B.E. (Agriculture) were started. In 1979, the faculty of Horticulture was established. In order to nurture the home-grown innovations, B.Sc. (Home Science) was started at Madurai campus in 1980. This degree was later renamed as B.Sc. (Food, Nutrition and Dietetics) from 2017 onwards based on the recommendation of ICAR. The third Agricultural College was started at Killikulam in 1984 and the fourth at Navalur Kuttappattu, Tiruchirappalli in 1989. An exclusive B.Sc. (Forestry) program was started in 1985 at the Coimbatore campus and later relocated to Forest College and Research Institute, Mettupalayam in 1991. Later, B.Sc. (Horticulture) program was shifted to Periyakulam (1990) and B.E. (Agriculture) was shifted to Agricultural Engineering College and Research Institute, Kumulur (1992). The B.E. (Agriculture) program was renamed as B.Tech. (Agricultural Engineering) in 2002. A new Horticultural College and Research Institute for Women was established during 2011 at Navalur Kuttappattu, Tiruchirappalli offering B.Sc. (Horticulture). A unique program, B.Sc. (Sericulture) was started in 2011 at Agricultural College and Research Institute, Coimbatore and is being now offered at Forest College and Research Institute, Mettupalayam.

In the backdrop of changing agricultural situation and developments in science and technology, TNAU introduced unique technology programs viz., B.Tech. (Food Process Engineering) during 1998, B.Tech. (Biotechnology) during 2002, B.Tech. (Energy and Environmental Engineering) during 2004, B. Tech. (Bioinformatics) during 2006, B.S. (Agribusiness Management) and B. Tech. (Agricultural Information Technology) during 2007.

Three more constituent agricultural colleges viz., Agricultural College and Research Institute, Eachangkottai, Thanjavur, Agricultural College & Research Institute, Vazhavachanur, Tiruvannamalai and Agricultural College & Research Institute

Kudumiyanmalai, Pudukkottai were started during 2014. In addition to this, B.Tech. (Agricultural Engineering) is being offered by Agricultural Engineering College & Research Institute, Coimbatore since 2019 in self-supporting mode. From the academic year 2021-22 onwards two programs B.Sc. (Hons.) Agriculture (Tamil Medium) and B.Sc. (Hons.) Horticulture (Tamil Medium) are introduced at AC & RI, Coimbatore, and HC & RI, Coimbatore respectively. One Horticultural College HC & RI, Paiyur, Krishnagiri District offering B.Sc. (Hons.) Horticulture and three Agricultural Colleges viz., AC & RI, Karur in Karur District, AC & RI, Keezh Velur in Nagapattinam District, and AC & RI, Chettinad in Sivagangai District offering B.Sc. (Hons.) Agriculture were started during 2021. The details of constituent colleges and programs offered are appended in Tables 1 and 2 respectively. In addition, 28 private colleges are affiliated with TNAU and offering B.Sc. (Hons.) Agriculture and/or B.Sc. (Hons.) Horticulture programs (Table 3).

1.1.1 Non – minority Institutions

Sixty-five per cent of total seats in the affiliated colleges are filled by TNAU in general counseling. Please refer to Section 2.1.6 for the nativity requirement for these seats.

Thirty-five per cent of the total seats in the affiliated colleges are filled by the respective management. However, the candidate must have applied through TNAU online admission procedure. The nativity requirement (Section 2.1.6) does not arise for these seats under the management quota.

1.1.2 Minority Institutions*

Fifty per cent seats are filled by TNAU through general counseling and fifty per cent by respective management. The minority institutions must fill their management seats as per Government norms.

* The Status of minority institutions is subject to Government approval.

1.1.3 General instruction for admission under management quota

The responsibility of verifying the candidate's eligibility to the admission solely rests with the respective affiliated colleges. TNAU is not liable for answering to legal queries for discrepancies or deviations if any. However, the original certificates of the candidates admitted by the respective colleges will be verified by TNAU and if candidate is not satisfying the eligibility criteria as mentioned in Section 2.1, his / her candidature will not be considered even at a later stage. All seats filled in under management quota are subject to approval of TNAU.

2 ADMISSION DETAILS

2.1 ELIGIBILITY FOR ADMISSION TO ALL UNDERGRADUATE PROGRAMS

2.1.1 Educational Qualifications – Academic Stream

Candidates should have passed ALL the subjects in Academic stream of the Qualifying Examination with 10+2 years of schooling under Board of Higher Secondary Education of Government of Tamil Nadu / Central Board of Secondary Education / Council for the Indian School Certificate Examinations / other State Government Boards / other International Boards that are recognized as eligible (based on the subject eligibility) for the following degree programs:

- 1. B.Sc. (Hons.) Agriculture
- 2. B.Sc. (Hons.) Agriculture Tamil Medium
- 3. B.Sc. (Hons.) Horticulture
- 4. B.Sc. (Hons.) Horticulture Tamil Medium
- 5. B.Sc. (Hons.) Forestry
- 6. B.Sc. (Hons.) Food, Nutrition and Dietetics
- 7. B.Tech. (Agricultural Engineering)
- 8. B.Sc. (Hons.) Sericulture
- 9. B.Tech.(Food Technology)
- 10. B.Tech.(Biotechnology)
- 11. B.Tech.(Energy and Environmental Engineering)
- 12. B.Sc. (Hons.) Agri-Business Management
- 13. B.Tech.(Bioinformatics) and
- 14. B.Tech. (Agricultural Information Technology)

2.1.2 Ranking Procedure

The calculation of aggregate is based on the marks obtained by the candidate and not the grades. The candidate has to upload the mark sheet (in percentage) given by the appropriate authority. The subjects that have a mention as "additional subjects" in the mark sheet shall not be considered for eligibility and ranking.

Grace marks awarded will not be counted for calculating aggregate marks and ranking.

If the qualifying examination is other than Tamil Nadu Higher Secondary (HSC) Examination, normalization procedure as ordered in the Tamil Nadu Admission in Professional Educational Institutions Act, 2006 (Tamil Nadu Act 3 of 2007), G.O. M.S.190, Agriculture (AP.6) Department dt. 16.5.2007 and G.O.M.S.191 Agriculture, AP.6) Department dt. 16.5.2007 shall be adopted for computing minimum eligibility and ranking.

2.1.3 Determination of the inter se merit

In cases where more than one student has got the same aggregate marks in the general rank list, the *inter se* merit among such students shall be determined in the order of priority as specified below (G.O. (Ms.) No.191 (AP.6) Department dated 16.05.2007):

- 1. Marks out of 50 in Mathematics. If a student has not studied Mathematics, marks out of 50 in Biology or (Botany + Zoology)
- 2. Marks out of 50 in Physics
- 3. Marks out of 50 in Chemistry
- 4. Date of Birth Eldest first
- 5. Random Number

2.1.4 Higher Secondary Course (HSC) – Vocational Stream

Five per cent of seats of B.Sc. (Hons.) Agriculture (English & Tamil medium), B.Sc. (Hons.) Horticulture (English & Tamil medium), B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering) at AEC&RI, Kumulur programs in TNAU Constituent and affiliated colleges (B.Sc. (Hons.) Agriculture (English medium) and Horticulture (English medium)), are exclusively reserved for candidates who have qualified under Tamil Nadu Vocational Stream and therefore they shall not be considered under general quota and any other special reservation categories. In this category both vertical and horizontal reservation policy will be adopted. The students who have studied the following Vocational group during their XII standard are only eligible for the degree programs indicated below:

- I. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology and Agricultural Practices as vocational subjects including theory and practical are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).
- II. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology, Agricultural Science Theory, Agricultural Science Practical and Computer Technology as vocational subjects are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).
- III. Candidates who passed Higher Secondary Course (HSC) under Vocational stream and studied Biology, Agricultural Science Theory, Agricultural Science Practical and Employability Skills as vocational subjects are eligible to apply for the degrees, *viz.*, B.Sc. (Hons.) Agriculture, B.Sc. (Hons.) Horticulture, B.Sc. (Hons.) Forestry and B.Tech. (Agricultural Engineering).

The aggregate calculation pattern followed for the academic stream applicants shall also be adopted for the vocational stream studied students. The marks obtained in all the four eligible subjects will be converted to 50 marks each and the aggregate mark will be arrived at.

In cases where more than one student has got the same aggregate marks in the vocational rank list, the *inter* se merit among such students shall be determined in the order of priority as follows:

- 1. Marks in Biology
- 2. Marks In Theory Subject
- 3. Marks in Practical Subject
- 4. Marks in Fourth subject
- 5. Date of Birth (Eldest First)
- 6. Random Number

Candidates who have passed Higher Secondary Course (HSC) under Vocational stream from other boards / other states are NOT ELIGIBLE for admission in Tamil Nadu Agricultural University.

2.1.5 Eligible Minimum Qualifying Marks (Academic Stream / Vocational Stream)

The following table (Table 7) lists the eligibility requirements concerning minimum qualifying marks for both academic and vocational streams of students.

2.1.6 Number of Attempts to Pass

The maximum number of permissible attempts to pass in the qualifying examination is as follows:

- Scheduled Castes / Scheduled Castes-Arunthathiyars / Scheduled Tribes:
 Three
- All other Communities: Two

2.1.7 Age Limit

Candidates should not have completed the age of 21 years on the first day of July of the admission year (*i.e.* as of 01.07.2024). However, for Scheduled Castes (SC), Scheduled Caste -Arunthathiyars (SCA), and Scheduled Tribes (ST) there is NO AGE LIMIT. Five years of age relaxation will be given for differently abled candidates.

2.1.8 Nativity

Candidates of Tamil Nadu Nativity only will be considered for general counseling. However, candidates who have studied 10th, 11th & 12th Standards in Tamil Nadu will be considered for admission, on producing proof of having studied 10th, 11th & 12th Standards in Schools located in Tamil Nadu.

Tamil Nadu candidates who have not studied 10th, 11th & 12th standards in Tamil Nadu should produce the Certificate of Permanent Residence in Tamil Nadu in the prescribed proforma (Appendix VII) issued by the competent authorities. Candidates possessing community certificate issued by the Government of Tamil Nadu need not submit Appendix VI.

2.1.9 Physical Fitness

A certificate regarding the physical standards prescribed shall be obtained from the Government Medical Officer and produced at the time of admission.

2.1.10 Discontinuing from Tamil Nadu Agricultural University (TNAU)

A student of Tamil Nadu Agricultural University who discontinues an undergraduate degree program at any stage of study after registering for the first semester is not eligible for admission again to any undergraduate programs of this University. Further, if the candidate discontinues after the completion of first-year first-semester examinations, he/she must pay a DISCONTINUATION FEE of Rupees TWO LAKHS (Rupees 2,00,000/- Only) to TNAU. This condition applies to all the students of constituent colleges and the students who joined affiliated colleges through the TNAU counseling quota. This condition does not apply to the students admitted under the Management Quota in Affiliated colleges.

2.2 RESERVATIONS

2.2.1 Category-Wise Reservation

The reservations will be followed as per the orders of the Government of Tamil Nadu in vogue at the time of admission.

Tamil Nadu Ordinance No. 4 of 2007 published in the Tamil Nadu Government Gazette extraordinary No. 262 dt. 15.09.2007 provides for reservation in respect of annual permitted strength in each branch or faculty for admission into educational institutions in the State including private educational institutions. For the Backward Class Muslims it shall be three and a half percent within the thirty percent reservation for Backward Class as provided in the 1994 Act and in 2006 Act.

- (c) Community Certificate obtained from other states will not be considered for communal reservation.
- (d) For communities linked with Districts, the candidates should obtain their community certificate in the respective district except the communities mentioned in G.O. (ST) No. 95 BC, MBC & Minorities Welfare Department dt: 28.10.2009. Such of those

- community certificates obtained on or after 28.10.2009 will be considered. Community certificate obtained from other than the respective district will not be considered.
- (e) Candidates who have not produced the Community Certificate in the form of Permanent Community [Card] Certificate or electronic form / digitally signed e-Certificate at the time of original certificates verification, their application will be treated under "Open Competition (OC)". The candidate is further informed that in the event of such a decision, the eligibility conditions & rules prescribed for OC will be applicable for such candidates and if such candidates do not satisfy the rules of OC, their applications are liable to be rejected. No correspondence in this connection will be entertained.

2.2.2 Special Reservations

A certain number of seats is also reserved for the following categories, as prescribed by the Government of Tamil Nadu G.O. Ms. No. 167 dt. 25.4.2008. A separate certificate with necessary details issued by the competent authority concerned has to be uploaded during the online application process and compulsorily produced at the time of certificate verification. A special processing fee of Rs.100/special reservation (except 7.5% quota) is to be paid along with the online application fee.

<u>Campus transfer is not permissible for candidates admitted under a special reservation quota under any account/circumstances.</u>

Since the special reservation applications require processing by separate committees, candidates are instructed to produce a Signed Application Form (generated on submission of online application) along with necessary original documents and appendices concerned to the Dean (Agriculture) and Chairman (Admissions), Tamil Nadu Agricultural University, Coimbatore on a stipulated date, which will be intimated to the candidate through the registered email id and mobile number. If the originals of the scanned certificates or supporting documents, already uploaded are not produced for verification, their claim under such categories will not be considered. The scheduled date of certificate verification will be updated on the website and will be intimated to the candidate through their registered email and mobile number. The candidates who applied for these special reservations shall also be considered for general counseling in case of their non-selection or the candidate is not willing to join. In such a case, the candidate must submit a request letter to this effect along with the parent's/guardian's signature.

2.2.3 Differently Abled

Five percent of the seats are reserved for differently abled candidates in the UG degree programs offered at the constituent colleges. The differently abled candidates with only lower limb disability (locomotor disability). The disability percentage for lower limb (locomotor disability) ranges from 40% to 60% shall alone be considered eligible. Candidates with less than 40% disability shall only be considered under their respective communal category. Though a differently abled applicant has lower limb disability (locomotor disability) with the admissible range of 40-60% if the disability-associated factors (with or without any other disability) that affect the applicant's study and increase the life risk to the candidate, his/her application shall not be considered for admission.

This condition shall be verified by a medical team at the time of application scrutiny. Applicants should fulfill all the other qualifying requirements. However, the maximum age limit is relaxed to 26 years (as of 1st July 2024).

Candidates seeking admission against this reservation set apart for Orthopedically Differently Abled (lower limb disability - disability percentage range: 40-60%) should produce the certificate issued by the District Medical Board concerned certifying the nature and extent of disability in percentage. Certificates obtained from an individual Doctor will not be considered. Further, a separate TNAU Medical Team will examine the candidates concerning their certificates and his/her suitability for admission to TNAU. Candidates must produce a Signed Application Form along with Appendix V (generated on submission of online application) and Medical Certificate on a stipulated date and time.

2.2.4 Ex-servicemen

One seat for each of the degree programs in all constituent colleges is reserved for sons and daughters of Ex-servicemen. This quota is not available for self-supporting courses. The applicants should possess all qualifying requirements and should upload the proof of evidence issued by the competent authority. Candidates must produce Appendix IIIa, Discharge Certificate, and Ex-serviceman ID cards of their parents for verification. Candidates claiming admission against the reservation of seats under this category should produce the certificate of dependency on Ex-servicemen in the prescribed format appended in the website www.esmwel.tn.gov.in

2.2.5 Eminent Sportsperson

One seat for each of the degree programs in all constituent colleges is reserved for eminent sportspersons. This quota is not available for self-supporting courses. The applicants should fulfill all qualifying requirements and produce proof of evidence and copies of the certificate issued by the Sports Development Authority of Tamil Nadu.

Certificates obtained at the International / National / State level will be considered on the order of merit. The purpose of this quota is to recognize the sports eminence of the candidates and hence marks for sports achievements alone will be considered for ranking the candidates. The candidates are expected to continue good performance in sports, after their admission to Tamil Nadu Agricultural University. Candidates seeking admission against the special reservation of seats under eminent sportsperson should produce Appendices VIa and VIb.

The highest achievement in a year for each of the last four years will alone be considered. A candidate can list a maximum of FOUR highest achievements. Preference for submission of certificates fully rests with the candidate. Selection of the candidate will be based on the sports marks obtained by following the guidelines given in Appendix XI. In case of a tie in the sports marks, the aggregate mark of the candidate (as described in Section 2.1.2) followed by date of birth (elder first) will be considered for ranking.

2.2.6 State Government School Quota

Seven and a half percent (7.5%) of seats on a "preferential basis" are reserved for students from State government schools in admission to all undergraduate courses both in constituent and affiliated colleges of Tamil Nadu Agricultural University. These students (academic and vocational stream) should have continuously studied from Class 6 to 12 in the State Government Schools of Tamil Nadu. Candidates who seek admission under this

quota should furnish his/her EMIS number at the time of filling online application. The eligibility for admission under this quota will be verified by the Government of Tamil Nadu based on the EMIS number. Admission will be awarded only to the Government of Tamil Nadu-approved eligible applicants. Therefore, TNAU will not hold responsibility for the mistakes made in the EMIS provided by the candidates at the time of application filling. The candidates who do not have an EMIS number should obtain and upload a bona fide certificate in the prescribed format provided in Annexure X.

2.2.7 INDIAN COUNCIL OF AGRICULTURAL RESEARCH (ICAR) QUOTA (Supernumerary)

Twenty percent of the sanctioned seats are allotted to the Indian Council of Agricultural Research, New Delhi for filling candidates through the National Level Entrance Examination for programs *viz.*, B.Sc. (Hons.) Agriculture (English medium) at Coimbatore, Madurai, Trichy, Killikulam, Eachangkottai, Kudimiyanmalai and Vazhavachanur (except Karur, Keezh Velur, and Chettinad), B.Sc. (Hons.) Horticulture (English medium) at Coimbatore, Periyakulam and Trichy (except Paiyur), B.Sc. (Hons.) Forestry and B.Sc. (Hons.) Sericulture at FC&RI, Mettupalayam, B.Sc. (Hons.) Food Nutrition and Dietetics at CSC &RI, Madurai, B.Sc. (Hons.) Agri Business Management at AC & RI, Coimbatore, B.Tech. (Biotechnology) at AC & RI, Coimbatore, B.Tech. (Food Technology) at AEC & RI, Coimbatore and B.Tech. (Agricultural Engineering) at AEC & RI, Kumulur. The processes of admission and filling of vacancies lie with ICAR and TNAU does not rest with any responsibility.

2.2.8 INDUSTRY SPONSORSHIP AND NON-RESIDENT INDIAN (NRI) QUOTA - Supernumerary

Candidates satisfying minimum mark requirements and maximum age limit can apply for either NRI or Industry Sponsorship quota. A candidate cannot apply for both NRI and industry sponsorship quotas. The distribution of seats for each degree program under the industry sponsorship and Non-Resident Indian quota is given in Table 2 in page numbers 4 & 5. There will be a separate counseling for these quotas and seats are allotted on a mark merit basis among the applicants under these categories and not on the communal reservations.

The candidates should have minimum educational qualifications as prescribed in Section 2.1.3. The upper age limit as prescribed for general counseling is applicable.

The candidates are requested to upload scanned copies of the necessary documents and appendices during the online application process. The originals should be produced at the time of verification which will be intimated through the registered SMS and email.

Industry Sponsorship Quota (Supernumerary)

A member of the Agribusiness Consortium of TNAU can nominate only one candidate for admission to the Undergraduate Program. Candidates of Indian Nationality alone are eligible to apply.

Any public / private limited industry directly related to agricultural manufacturing / production-related activities can sponsor one candidate once in four years by becoming a member of the Agri-Business Consortium (ABC) of Tamil Nadu Agricultural University, Coimbatore.

The industry willing to sponsor the candidate must be registered under the Companies Act and produce the following documents (Appendix XII):

- A letter expressing willingness to become a member of ABC addressed to The Secretary (Agri-Business Consortium) and Chairman (Admission), Tamil Nadu Agricultural University, Coimbatore-3. (Appendix XV)
- 2. Photocopy of Sales Tax Registration Certificate (GST)
- 3. Authorized signatory attested photocopy of PAN card along with Director Identification number of the sponsoring Company.
- 4. Self-attested photocopy of PAN card and Director Identification Number of the authorized signatory.
- 5. Company auditor attested photocopy of Audited Balance Sheet for the last three years attested by company auditor (The financial year 2023-24, 2022-23 and 2021-22). (proof for company auditor is to be attached)
- 6. Photocopy of Income tax return statement for the last three years attested by company auditor / Authorized signatory. (Financial year 2023-24, 2022-23 and 2021- 22). If accounts have not been completed for the financial year 2023-24, proof of advance tax paid for 2023-24 and a letter from the company auditor stating the status of accounting for the financial year 2023-24 should be submitted. In case of a change of company auditor, the respective GBM copy resolution and acceptance letter from the new auditor must be produced.
- 7. In case of an exception for tax payment, a copy of evidence shall be produced.
- 8. Photocopy of Certificate of Incorporation.
- Photocopy of Article of Association and Memorandum of Association. (Proof for authorized signatory/change of Director if any is to be produced wherever necessary) and
- 10. Sponsorship letter (Appendix XIV)

Scanned copies of the originals must be uploaded at the time of the online application process. The originals must be produced at the time of verification which will be intimated later through registered mobile/ email.

A committee formed by the University will visit the sponsoring industry for verifying its genuineness and the expenditure incurred towards the visit of the committee (Rs. 25,000/- in the form of a Demand Draft drawn in favour of "The Dean (Agriculture), Tamil Nadu Agricultural University, Coimbatore", payable at Coimbatore) must be borne by the sponsoring industry. This sum must be paid at the time of submitting the documents as a bound copy.

At the time of admission, the industry should enter an MoU (Appendix XIII) with TNAU by signing an agreement in Rs.100/- non-judicial stamp paper and remit a **non-refundable** ABC membership fee of Rs. 12.00 lakhs (Rupees Twelve lakhs only) in the form of single Demand Draft drawn in favour of "The Dean (Agriculture), Tamil Nadu Agricultural University, Coimbatore", payable at Coimbatore. The DD shall be taken after the date of provisional selection. MoU Signing will be done only after the course selection in counseling and verification of necessary documents. MoU should be signed IN PERSON by the managing director of the industry. Upon admission, the candidate has to pay the semester fee as per the course.

Non-Resident Indian (NRI) Quota (Supernumerary)

The candidate can be a Non-Resident Indian or ward of an NRI or close direct relative of a Non-Resident Indian (NRI). The semester fee for students joining under NRI Quota is US Dollar (\$) 3300 per semester.

The following documents should be furnished for seeking admission under NRI quota (Appendix XVI)

- 1. A letter sponsoring* the candidate for admission to the UG program (Appendix XVII)
- 2. Attested copy of Passport with Visa details of the sponsor
- Proof for NRI to be obtained from the Indian Embassy of the respective country Note: Resident card / Green card / Permanent Resident card / Residence proof / Employment certificate/ OCI are not accepted as proof of NRI.
- 4. Proof of Relationship to the Candidate issued in the form of a Notarized affidavit (Appendix XVIII). The Notary should give the particulars of entry made in the register maintained by him.
- * If the sponsor returns to India before the completion of the Academic Period (four years) he / she must remit the entire balance amount in one lumpsum.

If any applicant after securing an admission under NRI/industrial sponsorship quota he/she is not eligible for a refund of Rs. 12 Lakhs or 3300 USD in case of his/her discontinuation or switching over to ICAR quota seat or any other institutions within the University or outside, at a later stage.

2.2.9 STUDY IN INDIA (Supernumerary)

A fixed number of seats is allotted for foreign students who seek admission through ICCR (Indian Council for Cultural Relations) as approved by the 139th Academic Council.

3 MODE OF SELECTION

The candidates have to fill in their choice of degree program and college at the time of online application filling based on which admission will be allotted.

3.1 ONLINE COUNSELING

Selection process for general reservation candidates is done only through online counseling.

- During online counseling, the candidates will be allotted the Degree and College, based on their rank, community, and choice preferences made by them at the time of application filling, as per the procedure given in section 2.1.1.a.
- An online counseling system will be followed for all Degree programs.
- After the release of the rank list, candidates shortlisted will be informed through SMS and e-mail. The ratio of 'number of vacant seats (seats to be filled)': 'number of candidates shortlisted for counseling' will be normally 1:5. CALLING FOR ONLINE COUNSELING DOES NOT GUARANTEE A SEAT.
- Shortlisted candidates must pay a non-refundable counseling fee of Rs.3000/- (Rs. 1500/- for SC / SCA / ST categories) throu
- gh their login credentials (http://tnagfi.ucanapply.com). Those who fail to pay the counseling fee will not be considered for online counseling.

- During online counseling, the candidate is permitted to change the order of preference for Degree and College ONLY ONCE (as many times as he/she wants but the final submitted options will alone be considered for further processing). An SMS and e-mail will be sent to the candidates in this regard (repeat in the next para). No modification is possible in subsequent counseling/ upward movement sessions. If no modification is done, in the choice of College and Degree program, the preferences exercised while applying the online application will be considered for seat allotment.
- On the expiry of the online counseling date of the respective phase, the degree and college allotment will be done based on the final choice exercised and submitted by the candidate, merit, and communal reservations. The allotment will be informed to the candidates through SMS and e-mail. The detailed instructions on admission fee payment, downloading of the allotment letter, and documents required for verification and submission will be informed through registered email.
- The candidates who registered (Counseling fee paid) for online counseling and did
 not get any seat allotment in the first round of counseling, will be considered for
 allotting a seat during the subsequent upward movement process if a vacancy
 arises.
- After the online counseling, candidates will be called for certificate verification and submission before the stipulated time as specified by the Chairman (Admissions) to confirm their seats allotted to them.
- Before appearing for certificate verification at TNAU, Coimbatore, the candidates are required to pay an amount of Rs. 20,000/- towards the admission fee by online mode. Only on successful payment of admission fee, the allotment letter can be downloaded. This amount will be adjusted in their first-semester fee. Paying the admission fee does not guarantee the confirmation of a seat. Confirmation will be done only after the verification of certificates/documents and their submission before the stipulated time. A provisional admission card will be issued after successful verification.
- The admission fee (Rs.20,000/-) is REFUNDABLE if the candidate has not registered the first semester of the degree program. And is non-refundable if a candidate withdraws his/her already secured admission under the government quota and is willing to get an admission under the management quota in an affiliated college.
- If any information (Marks and qualification, Community, Date of Birth, Nativity, etc.,) is found incorrect, the candidature will summarily be rejected. If the candidate is willing to secure an admission further, he/she will be called for a re-counseling based on his/her revised credentials. Delay or absence for submission of certificates/documents and payment of fees will result in cancellation of the secured seat.
- Separate IN-PERSON counseling will be conducted at TNAU Coimbatore for special reservations (Differently abled, Eminent Sportsperson, Ex-servicemen, NRI, and Industrial Sponsorship quotas) and general counseling based on necessity
- Candidates of Tamil Nadu nativity, who have applied for any one of the special reservations, are also eligible for general counseling.

3.1.1 Upward movement system

- When a vacancy arises, based on the choice exercised and willingness expressed for upward movement, at the time of document verification, candidates will be moved to their best preferred upward choice of Degree and College based on merit and communal reservation.
- An upward movement system will be followed for all counseling based on vacancy.
- Once opted for upward movement either it cannot be stopped in between or withdrawn

3.2 OFFLINE COUNSELING

Offline counseling will be conducted for Special reservations (Differently abled, Eminent Sportspersons, and Ex-servicemen), NRI, and Industrial Sponsorship quota. Offline Counseling for Differently abled, Eminent Sportspersons and Ex-servicemen will be conducted ahead of general counseling. Counseling for NRI and Industrial Quota will be conducted after one or two phases of general counseling.

Candidates attending special reservation counseling have to bring the necessary original document/certificate pertaining to their special reservation. If valid/original documents are not produced by the candidates during the counseling, they will not be allowed to attend the counseling process.

3.2.1 Offline Counseling Process

Candidates can choose the Degree and College, based on their rank during OFFLINE counseling. Attendance of candidates will be marked both at the entry and exit. Candidates have to opt for a degree and college available at the time of counseling. DEGREE AND COLLEGE CHOICE ONCE MADE IS FINAL AND CANNOT BE CHANGED. Upward movement options will be obtained from the candidate. Candidates who have attended counseling and did not select any choice will be not considered for future counseling phases in the academic year. CALLING FOR COUNSELING DOES NOT GUARANTEE A SEAT. TA and DA will not be given for attending counseling.

The following options exist for the candidate at the time of offline counseling:

Note: THERE IS NO WAIT LIST OPTION IN THE COUNSELING PROCESS

Candidates who fail to attend the counseling at the specified date and time will forfeit their right to admission. However, due to unforeseen and unavoidable reasons, if a candidate is unable to attend the counseling on the specified date and time, the candidate

can authorize their parent/guardian on their behalf and the parent's /guardian's decision will be binding and final. Such authorization letter should bear photographs of the candidate and authorized person (candidate's parent/guardian) and be signed by both the candidate and authorized person. The authorized person attending the counseling on behalf of the candidate should carry the counseling letter and photocopy of the ID proof. On-demand, the authorized person has to produce the ID proof in original for verification. The format for the authorization letter is provided in Appendix XIX.

3.3 Supplementary application

A need-based supplementary online application portal will be opened for 2-3 days after the declaration of supplementary exam results by the Tamil Nadu higher secondary board. The candidates who missed to apply earlier to TNAU and passed afresh through the supplementary examination can apply. The residual seat matrix arrived after general counseling / spot admission(s) shall be utilized for admitting supplementary applied candidates. The admission steps followed for the general counseling shall be adopted for this admission as well. The rights to decide to provide the supplementary application option and its duration, need-based modifications to the admission steps, and the various time stipulations for these admission steps are reserved with Tamil Nadu Agricultural University and its Chairman admissions.

The implementation of this supplementary application procedure is subject to the approval of the Government and the issuance of the Government order.

3.4 Spot Admission

As per the directions of the Hon'ble Justice Prabha Sridevan Committee (G.O.Ms.No.3 Agriculture (AU) Dept. dated 07.01.2020), Spot Admission will be conducted for the vacant seats of affiliated colleges after the opening of the colleges. Spot admission is an offline counseling process. Spot admission applies only to affiliated colleges. The vacancies in the constituent colleges will be kept vacant. No upward movement process will be followed. For spot admission, counseling fees will be collected only from the candidates who availed a seat. After selection, the candidate must pay the counseling fee as prescribed above.

The vacancy position, college-wise and community-wise will be published on the TNAU website on the day of spot admissions and also given as a press release for a larger reach. Candidates will be called in a ratio of 1: 10 or more depending on the situation. Applied candidates who have not attended the counseling earlier or those who have not got a seat in the general counseling or already secured admission under the management quota can attend the counseling. Applicants who already secured admission but cancelled their seats or discontinued or secured an admission are not eligible. TA and DA will not be given for attending counseling. Attendance will be marked and a ranking of attended candidates will be done. Candidates will be called based on their rank for choosing the college and seat.

Selected candidates must join the college immediately by submitting the educational certificates and by paying an admission fee of Rs. 20,000 which will be facilitated on the university campus itself on the day of spot admission. Calling for Spot Admission does not

necessarily GUARANTEE a seat. No candidate will be admitted after the announcement of "Completion of Admission" for the academic year.

During the spot admission, if any management seat falls vacant due to the migration of students from the management quota seat to the counseling quota, the management of the affiliated colleges is at liberty to fill up such vacancies within five days of the closure of TNAU admission.

3.5 FILLING OF NON SURRENDED MANAGEMENT SEAT

After the commencement of college, an additional 20 days (date of registration will be counted as day 1) shall be given to the affiliated colleges to fill the non-surrendered management seats to the spot admission. The affiliated colleges can admit only the applicants who have applied to TNAU to fill their non-surrendered management quota seats.

4 SYSTEM OF EDUCATION

The medium of instruction is English in all colleges except for the Tamil medium students of AC&RI, Coimbatore, and HC&RI, Coimbatore and the evaluation pattern in the University is "Semester Course Credit System". All Undergraduate Programs are eight Semesters (4 years) duration. An enrolled student to earn a Bachelor's Degree should complete the course credits prescribed from time to time and should have earned a minimum Overall Grade Point Average (OGPA) of 6.50 out of 10.00.

The e-learning initiatives in TNAU necessitate the use of laptops for learning as well as for assignments. Admitted candidates may preferably have a laptop throughout their courses of study.

5 RAGGING

Ragging in any form, place or time is a cognizable offense that will attract severe punishment, including summary expulsion from the institution. (Tamil Nadu Government Gazette Extraordinary dt.29.01.97, Bill No. 8 of 1997, Tamil Nadu Publication of Ragging Act.). Hence, TNAU shall make all institutional arrangements to check ragging in all constituent and affiliated campuses.

6 FEE AND DEPOSITS

Each admitted candidate is required to pay fees according to the institute and degree program to which they are selected.

The admission fee of Rs. 20,000/- collected during the time of seat allotment will be adjusted with the Semester fee. The difference of amount has to be paid by the candidate before registration at the time of college opening at the respective institutes.

6.1 Fee Structure for Constituent Colleges of TNAU

A1. Science Programs

The following seven undergraduate degree programs, namely, B.Sc. (Hons.) Agriculture (English and Tamil medium), B.Sc. (Hons.) Horticulture (English and Tamil medium), B.Sc. (Hons.) Forestry, B.Sc. (Hons.) Sericulture, B.Sc. (Hons.) Food, Nutrition and Dietetics and B.Tech. (Agricultural Engineering) at AEC&RI, Kumulur are treated as Agricultural Science programs for the purpose of fee.

A2. Technology Programs

The following four undergraduate degree programs, namely, B.Tech. (Food Technology), B.Tech. (Biotechnology), B.Tech. (Energy and Environmental Engineering), B.Sc. (Hons.) Agri Business Management), B.Tech. (Agricultural Engineering), B.Tech(Bioinformatics) and B.Tech (Agricultural Information Technology) at AEC&RI, Coimbatore are treated as Agricultural Technology programs for the purpose of fees.

6.2 Fee for Affiliated Management Colleges

Candidates admitted through counseling and management quota in the Affiliated colleges have to pay an all-inclusive, annual tuition Fee of Rs. 50,000/- as fixed by the Government of Tamil Nadu (G.O. (Ms.) 233 of Agriculture (AU) department dated 8.10.2020).

6.3 Refund of semester fee

Students discontinuing the program before registration are eligible to get a full refund of the semester fee. Those who discontinue after registration are eligible to get a refund of only the caution money deposit from their respective campuses.

7 SCHOLARSHIPS

Fee concessions and scholarships such as Adi Dravidar welfare scholarships, Central Government scholarships, State Government free education for students from non-graduate family, Periyar Endowment scholarships and fellowships and scholarships from the Indian Council of Agricultural Research, New Delhi and other agencies are available for the benefit of deserving enrolled candidates. These may vary according to the degree / college to which candidates are admitted and respective funding agencies.

8 FACILITIES AND RESTRICTIONS

- Campus transfer is not permissible.
- Separate hostels for men and women are available in each campus with WiFi Internet connectivity. Specified uniform is mandatory for classes / field / lab work.
- Students run messes on a dividing system basis.
- All students are expected to reside in the hostel attached to the respective colleges.
 In exceptional cases, the Dean is empowered to permit students to be day-scholars.
- A Students' Centre with a canteen is available in each campus to provide stationery and essential items.
- Infrastructure facilities exist in all colleges for extra-curricular activities.
- Library and sports facilities are available in all campuses.
- Students are not allowed to own and drive motorcycles/car in the campus failing
 which the students will not be given hostel accommodation. Parking vehicles
 elsewhere in the campus and usage is also equally punishable. An undertaking is
 this regard in enclosed in the proforma XIII in which both parent and student have
 to sign.
- Mobile phones are banned in the classroom.

9 REPORTING TO ADMITTED COLLEGES

Newly admitted students should report to the allotted college in the scheduled time as given in the admission letter/ as per upward movement, failing which their admission will be cancelled. No exemption or permission will be entertained in this regard.

10 DISPUTE REDRESSAL

With regard to the interpretation of the provisions of any matter not covered in this information brochure, the decision of the University shall be final and binding on all the parties concerned. Any complaints, grievances etc., related to UG admissions and academic matters must be first referred to the Chairman (Admissions) and Dean (Agriculture), Agricultural College and Research Institute, Coimbatore who will be the appellate authority to redress such complaints /disputes. The Courts having their jurisdiction at Coimbatore alone can adjudicate on all matters and disputes related to admissions and academic matters (Candidates applied for TNAU/TNAU & TNJFU and admitted in TNAU). Further, any legal question arising out of the admission shall be entertained only when raised within 30 days from the declaration of the result. No Disputes will be entertained after the closure of admission.

The Private colleges/institutes affiliated to TNAU are not authorized to admit any candidate against the seats allotted under the government quota of 65% or 50% as the case may be, without specific prior approval of the Government of Tamil Nadu and TNAU. TNAU is not liable and legally binding for any admissions made under the lapsed seats violating the rules and regulations prescribed by the Government of Tamil Nadu/TNAU for the admission of the candidates under government quota seats. The candidate admitted without the University approval and violating the above rule, will not be treated as students of TNAU and cannot claim any right from TNAU.

TNAU will not be responsible for the return of the certificates, or any fee remitted by the candidates admitted under the Management Quota by the private colleges/institutes affiliated to TNAU. Nothing is binding for TNAU for any of the legal issues raised by the students admitted under Management quota against the management, related to issues of certificates, fee remitted etc.
